Subject to the conditions and limitations stated below, LATICRETE INTERNATIONAL, INC. ('LATICRETE') warrants that the products listed on this document will be free from any manufacturing defects and will not break down or deteriorate under normal usage for a period of twenty-five (25) years from the date of purchase when installed in accordance with the written specifications of LATICRETE and industry standard guidelines.

For this limited 'system' warranty to apply, the applications that comprise the installation must be performed with the products listed in this document for each application (refer to chart). Please refer to individual product data sheets for specific guidelines.

Any warranty claim MUST be accompanyed by a letter of warranty from Laticrete Europe. This warranty offer applies ONLY to systems used in Europe.

Note: This 25 year warranty will only apply to external Masonry Veneers applied using the MVIS SYSTEM onto building structures of solid brick, stone and concrete construction. With regards to exterior facades of ceramic tile, stone, adhered masonry veneer, or thin brick installed over external or internal substrates within buildings of any function incorporating wood framed structural features, will only qualify for the Laticrete 15 year warranty (Ref: 230.15-0215E). No Warranty is given for Steel Framed structures.

EXCLUSIONS

LATICRETE is not responsible for workmanship not in accordance with the instructions of LATICRETE data sheets and local industry standard guidelines and building regulations. For UK the agreed code of practice guidelines is BS5385-2:2015 or BS5385-1:2009 - Design & Installation of External and Internal Ceramic Tile, Stone & Mosaic in Normal Conditions. Cracking due to structural movement, excessive deflection or other failure in the structural movubstrate is also not covered.

LATICRETE IS NOT LIABLE FOR ANY INCIDENTAL DAMAGES OR CONSEQUENTIAL DAMAGES, INCLUDING LOSSES DUE TO DELAYS, INCURRED BY THE PURCHASER OR ANY OTHER PARTY.

EXCLUSIVE REMEDY

The sole and exclusive remedy for a breach of this limited warranty is replacement of only the specific portion of the installation that is proven to be defective**. LATICRETE will pay for replacement of its own products and replacement of finishing materials, as well as for labor for the replacement installation, but LATICRETE will not pay more, calculated on a square-foot (square-meter) basis, for the replacement than the original purchase price of the portion being replaced. LATICRETE will not pay for replacement of any portion of the installation that is not proven to be defective.

In the event that the sole and exclusive remedy described above fails of its essential purpose, the liability of LATICRETE is limited to the monetary value, on a square-foot (square-meter) basis, of the original purchase price of the portion being replaced.

This limited warranty is not transferable or assignable.

HOW TO MAKE A CLAIM

To make a claim under this limited warranty, you must notify LATICRETE in writing within thirty (30) days of the discovery of the alleged manufacturing defect. At the option of LATICRETE, you may be required, as a condition of this limited warranty, to provide proof of product purchase and use.
