LATICRETE insists that the Knauf Aquapanel boards are installed to the manufacturers (Knauf UK GmbH) full guidelines before the LATICRETE system is used.

For this limited 'system' guarantee to apply, the applications that comprise the installation must be performed with the products listed in this document for each application (refer to chart). Please refer to individual product data sheets for specific guidelines or contact LATICRETE technical services. Any claim MUST be accompanyed by a letter of approval from Laticrete Europe. This guarantee offer applies ONLY to systems used in Europe.

If Hydro Ban is used as a system, a further manuafcturers guarantee is offered.
