Subject to the conditions and limitations stated below, LATICRETE INTERNATIONAL, INC. ("LATICRETE") warrants that the products listed on this document will be free from manufacturing defects and will not break down or deteriorate under normal usage for a period of twentyfive (25) years from the date of purchase when installed in accordance with the written specifications of LATICRETE and industry standard guidelines & codes of practice. For this limited "system" warranty to apply, the applications that comprise the installation must be performed with the products listed in this document of relevance for each application (refer to chart).

Note: This 25 Year warranty will only apply to approved external Masonry veneers applied using the MVIS system onto building structures of solid brick, stone & concrete construction. With regards to exterior facades of ceramic tile, stone, adhered masonry veneer, or thin brick installed over external or internal substrates within buildings of any function incorporating wood framed structural features will only qualify for the Laticrete 10year warranty. No warranty is given for steel framed structures.

This limited warranty is not transferrable or assignable.

## **DISCLAIMER**

THIS LIMITED WARRANTY IS GIVEN IN LIEU OF ANY OTHER WARRANTY, EXPRESS OR IMPLIED. THERE ARE NO WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WARRANTIES BASED ON SAMPLES OR ORAL STATEMENTS, WHICH EXTEND BEYOND THE DESCRIPTION ON THE FACE OF THIS DOCUMENT. IMPLIED WARRANTIES OF MERCHANTABILITY AND OF FITNESS FOR A PARTICULAR PURPOSE ARE EXCLUDED.

### **EXCLUSIVE REMEDY**

The sole and exclusive remedy for a breach of this limited warranty is replacement of only the specific portion of the installation that is proven to be defective\*\*. LATICRETE will pay only for the replacement of its own products and any finishing products directly damaged from being in contact with them, but LATICRETE will not pay more, calculated on a square metre basis, for the replacement than the original purchase price of the portion being replaced.

LATICRETE will not pay for replacement of any portion of the installation that is not proven to be defective. In the event that the sole and exclusive remedy described above fails of its essential purpose, the liability of LATICRETE is limited to the monetary value, on a square-meter basis, of the original purchase price of only the portion of materials being agreed as in need of replacement.

### **EXCLUSIONS**

LATICRETE is not responsible for workmanship not carried out in accordance with the specific instructions of LATICRETE product data sheets; statutory industry standard guidelines; local authority building regulations and agreed codes of practice (BS 5385 Parts 1 to 5) "Design & Installation of external ceramic tile, stone & mosaic in normal conditions"). Any damages or cracking due to inherent faults identified within the finishing products, structural movement, excessive deflection, subsidence or the actions of ancillary works resulting in a failure in the substrate is also not covered. Laticrete is not liable for any incidental damages or consequential damages or losses which may be attributable to delays incurred by the purchaser or any other party.

\*\*NOTE: Efflorescence is a normal condition of Portland cement mortars and is not a defective condition.

LATICRETE reserves the right to withdraw any warranty where its' products have been specified or have been used & applied in circumstances which are outside of the products' intended scope of use, or where it is reasonably foreseeable that the products will be subject to exposure to elements & stresses either during their application, or throughout the service lifetime of the structure, which are either inappropriate or are other than in accordance with the agreed conditions of application & end use.
